C-PACE PROGRAM DISCUSSION

Seth Lutter from Montana Facility Finance Authority presented the C-Pace program. The mission is to enhance Montana healthcare and community capabilities through access to cost-effective capital financing and development services. C-Pace covers the costs of improvements that save energy, save water, and generate renewable energy. The role of Pondera County is to establish a special district and bill and receive property taxes, and in turn forward the funds to C-Pace, that serves as the agent of the county in respect to C-Pace projects. Much discussion was made on C-Pace. No action was made.

FOURTH DRAWDOWN FOR FEDERAL AVIATION ADMINISTRATION PROJECT PAYMENT

Commissioner Morren moved to approve drawdown #4 for the Federal Aviation Administration Project for the Pondera County Airport in the amount of \$13,538.63. The funds will pay Robert Peccia & Associates to be used towards the Pondera County airport planning grant. Commissioner Kuka seconded. Motion carried.

APPROVAL OF AIRPORT RUNWAY SNOW REMOVAL

Chris Sullivan of Sullivan Brothers Construction submitted a bid to clear the runway of snow and ice at the Conrad Airport for 2023. It is an "as needed per FAA requirements" agreement as it has been in the past. For the amount of \$600 per time. RESOLUTION REQUESTING AUTHORITY FOR DISTRIBUTION OF COUNTY MINIMUM ALLOCATION GRANTS FOR WATER AND SEWER INFRASTRUCTURE PROJECTS - VALIER

WHEREAS Section 4 of Chapter 401 of the Montana Session Laws of 2021 through House Bill 632 Section 4 allocated the amount of \$150 million of the coronavirus state fiscal recovery funds to be used to provide minimum allocation grants for water and sewer infrastructure projects eligible for funding under the American Rescue Plan;

WHEREA3 the amount a local government is eligible to receive in water and sewer infrastructure grants under this section is in the same proportion and using the same ratios provided for in 15-70-101 (2)(b), (2)(c), and (3) giving County a minimum allocation of \$606,605;

WHEREAS, HB 632 Section 4 requires that a local government submit an application for a qualifying water or sewer infrastructure project that complies with the uses authorized for the coronavirus state and fiscal funds and pledge matching funds;

WHEREAS Montana's counties do not generally own or operate water and sewer infrastructure;

WHEREAS grant funds must be applied for and awarded or in a pending status by January 1, 2023;

WHEREAS, because counties generally do not own water and sewer infrastructure, HB 632 Section 4 allocated grant funds for qualifying water or sewer infrastructure projects within the counties for which it was allocated, but that any local government eligible to receive minimum allocation funds under HB 632 Section 4 could apply for and pledge matching funds for the county's proportion.

WHEREAS, the Town of Valier is a local government as defined in HB 632 Section 4 and has committed to request the funds, if the county's allocation made eligible to them and the county has determined this to be a priority use of the allocated funds.

THEREFORE, NOW BE IT RESOLVED THAT: Pondera County has determined that the proposed Project is eligible as a minimum allocation project and is a high priority within the county and By this resolution, Pondera County requests the Department of Natural Resources and Conservation allow, through its developed application and distribution processes, the Town of Valier \$210,000 of its share of the allocated Minimum Allocation funds for the town's wastewater system improvement.
