The Board of Pondera County Commissioners met daily in informal session and in scheduled meetings on March 6, 13, 20 and 27, 2024.

MARCH 6, 2024 REGULAR MEETING OF THE COMMISSION:

Commissioner Morren called the hearing to update Pondera County Subdivision Regulations to order at 10:00 a.m.at the Pondera County Commissioners office, 20 4th Ave SW, Conrad.

There was discussion on the new section outlining an Expedited Minor Subdivision Review process. There were no written or oral comments from the public for or against adopting the proposed Subdivision Regulations.

The hearing adjourned at 10:05 a.m.

PUBLIC COMMENT

Brady Methodist Church members discussed the options for the road drainage near the church. Frosty DeBoo suggested a route for the drainage using pipe the Road Department already has in the Conrad yard.

Jim Schlosser discussed the possible construction of a major subdivision in the Norman Subdivision for more retirement housing.

SPECIAL MEETING FEBRUARY 29, 2024

Commissioners met with representatives from Calumet, Montana Renewables and Montana Fluid on the EPA waste water. Dave Galt, lobbyist from Calumet, was present.

APPOINTMENT OF RURAL FIRE DISTRICT BOARD OF TRUSTEES

The Rural Fire District Board members are elected to their positions. Montana law provides that if the number of candidates is equal to or less than the number of positions to be elected, the election administrator may cancel the election. In such case, the county governing body shall declare elected by acclamation each candidate who filed a nominating petition for a position. If a nomination is not made for one or more trustee offices, the county governing body shall appoint one or more trustees as necessary to fill those offices. A trustee taking office pursuant to this subsection serves the trustee term of office as if that trustee had been elected.

Ernie Boumans and Jim DeStaffany each filed a Declaration For Nomination. In accordance with Montana statute, Commissioner Kuka moved to declare Ernie Boumans and Jim DeStaffany elected by acclamation, each for a term of three years. Commissioner Drishinski seconded. Motion carried.

OPENED ENGINEERING QUALIFICATION SUBMISSIONS

Requests for Engineering Qualifications for a Principal Consultant to provide General Engineering Services for Pondera County were opened. The Consultant selected must provide environmental services, design, construction inspection coordination, and

administration of all project stages for a variety of projects for a term of five years. Submissions were received from Heberly/Triangle Engineering and Stahly Engineering. Commissioner Kuka moved to take the submissions under advisement and review. Commissioner Drishinski seconded. Motion carried.

EXPENDITURES IN EXCESS OF \$500-APPROVED

Commissioner Kuka moved to approve the purchase of a paper folding machine for the Election Department, in the amount of \$565.81. Commissioner Drishinski seconded. Motion carried.

AMENDING THE PONDERA COUNTY SUBDIVISION REGULATIONS ADOPTED OCTOBER 16, 2016 TO REFLECT LEGISLATIVE CHANGES TO THE MONTANA SUBDIVISION AND PLATTING ACT IN 2023.

WHEREAS, Pondera County wishes to update its subdivision regulations in accordance with current law; and

WHEREAS, a hearing was conducted on the proposed changes on March 6, 2024 and notice of the hearing was published in The Independent-Observer and The Valierian in the February 21 and 28, 2024 issues.

WHEREAS, on February 21, 2024, the proposed adoption of the Pondera County Subdivision Regulations (along with the changes made) was made available for public review.

WHEREAS, the public hearing and adoption of resolution was included in the posted Agenda of the regular meeting of the Pondera County Commissioners and there were no public comments received.

NOW, THEREFORE, BE IT RESOLVED, the Board of County Commissioners hereby adopt the Pondera County Subdivision Regulations, effective March 6, 2024.
