<b>Authentication/Exemplification</b> – For authenticated or exemplified copies for out of state jurisdictions	\$ 6.00
<b>Certification</b> – For Certification with a Seal	\$ 2.00
<b>Civil Commencement of Action</b> – For each action or proceeding from the plaintiff, petitioner, or appellant (includes Invalidity)	\$120.00
